Legal Description: Being Lots 510 & 511 Fairmount Land Gas & Improvement Company's 4<sup>th</sup>

Addition and located in the Southeast Quarter of Section 29 in Fairmount Township.

Request: to allow one two-story duplex (4 dwelling units) per lot on a site of 13,305 SF instead

of the required 24,000 SF (per a request from the board at the September 9 meeting).

Docket: 10BZAV-19 (Public Hearing) Name: Cory & Shannon Zirkle

Address: 3091 W 975 S, Fairmount Zoning District: Agriculture (AG)

Legal Description: Being .934 acres, more or less located in the Southeast Quarter of Section 28

in Liberty Township

Request: To allow an accessory building addition to be 0' from the west property line instead of

the required 18' and to be 0' from the rear property line instead of the required 5'.

Larry Strange introduced the request for petition and provided an overview.

Cory Zirkle represented the petition and answered questions from the board.

Mark Hasty spoke in opposition. He farms the land (he is not the owner) and wanted at least a three-foot buffer because if the building is right on the line his farm equipment may have issues with the smaller turns and it may end up damaging the addition to the accessory building.

The public hearing was closed.

**Motion:** Rex Maynard moved to approve Docket #10BZAV-19 be continued until the next meeting with a new plan to have at least a 3' buffer off the property line and Bill Johnson. Since there were not enough members to consider a motion the docket was prorogued (deferred) to the November meeting.
