Name: Sweetser United Methodist Church Address: 413 N Main Street, Sweetser Zoning District: Residential-3 (R3)

Legal Description: Being located in the Northwest Quarter of Section 8 in Center Township **Request:** Requesting a variance to place a sign that is 48 sf instead of the allowed 8 sf and will be animated/digital print sign which is not allowed in residential zoning.

The church decided to withdraw until the Sign ordinance has been approved and then they will apply for a rezoning and special exception.

5.1.1 Director Malott noted the Church had agreed to withdraw the application while the APC works thru drafting of a "Digital/Animated" Sign Ordinance Amendment. Director Malott noted that the Areawide Ordinance would call for a Six Month wait time before refiling, but hoped the BZA was allow less time if he could get the sign ordinance amendment completed & adopted.

Kyle checked on 2.1.4 through 2.1.5.6 of the Rules of Procedure regarding Classification of use. The Board discussed what needed to be done with this section and decided that it should be removed. Director Malott showed the Board how the office checks the NAICS for a classification and then going to the Authorized Use Table for the zoning use & classification. Lois Jones made the motion to remove Sections 2.1.4 through 2.1.5.6, and Bill Johnson seconded. Members Chip Long, Rex Maynard, Lois Jones, Ron Howe, and Bill Johnson, voted yes. Motion carried.

Appeals – Lois Jones motioned that the appeals be changed to the red version (Indiana Code) and Rex Maynard seconded.
